MINIMUM QUALIFICATIONS

Education: Minimum of Bachelor Degree in Health and Physical Education. Valid Georgia Professional Teaching Certificate.

Essential Knowledge/Skills: Extensive knowledge of human growth and development patterns and implications for instruction; ability and training necessary to effectively utilize available resources, including technology in the planning, implementation, and evaluation of instruction; knowledge of sound educational research and practices in area of expertise; continuous staff development and participation in workshops, classes or other activities designed to improve skill and performance and to stay abreast of current trends in area content and school improvement; ability to instruct students of all abilities with a high level of expectation for behavioral and academic standards and physical performance; ability to motivate students to be productive learners and challenge all students to meet world-class standards of educational excellence; ability to adapt and or modify instruction to include physical education; has knowledge of students with various special needs, disabilities, and disorders, and is able to prescribe remediation and evaluate student progress; has the ability to function as a member of an educational team, collaborate with general education staff, related services providers, support personnel, community agencies, and parents; possesses behavior management and positive discipline skills and is able to be flexible and receptive to change; is able to complete all duties related to the successful outcome of the Special Olympic Games; Schedules, coordinates, and travels to schools for appropriate Special Olympic events, community based sports, and provides expertise coaching in various sports including swimming, bowling, gymnastics, tennis, life skills.; Directs students in each sport and regulates the content of the program in accordance with each student’s needs and capacity to participate; Communicates and works with the classroom teacher and PE teachers regularly; Orders, maintains, and secures equipment for the APE and Special Olympics programs. Presides, serves, coordinates, and participates on the Special Olympic Advisory Board; Submits all reports, goals, budget and financial information to the State Special Olympic office and maintains Special Olympic accreditation; Plans, participates, and trains athletes to compete in the local, area, and state Special Olympic competitions; Coordinates fundraisers, sets budgets, and secures funds for the Columbia County Special Olympics program.

Experience: At least 3 successful years as a physical education or special education teacher (PE preferred)

GOAL

To use adaptive physical education techniques to instruct and inspire students with disabilities to enjoy the benefits of physical activities and to participate appropriately, at their level in assigned games, sports, and physical education. By doing so, students will improve gross and fine motor skills, perceptual motor skills, and sports and game achievement.

REPRESENTATIVE DUTIES & RESPONSIBILITIES

- I. Teacher Duties and Responsibilities
 - a. Follows professional practices consistent with school and system policies in working with students, students’ records, parents and colleagues
 - i. Interacts in a professional manner with students and parents
 - ii. Is available to students and parents for conferences according to system policies
 - iii. Facilitates home-school communication by such means as holding conferences, telephoning, and sending written communications

- iv. Maintains confidentiality of students and students' records
 - v. Works cooperatively with school administrators, special support personnel, colleagues, and parents
 - b. Complies with school, system, and state administrative regulations and board of education policies
 - i. Conducts assigned classes at the times scheduled
 - ii. Enforces regulations concerning student conduct and discipline
 - iii. Is punctual
 - iv. Provides adequate information, plans, and materials for substitute teacher
 - v. Maintains accurate, complete, and appropriate records and files reports promptly
 - vi. Attends and participates in faculty meetings and other assigned meetings and activities according to school policy
 - vii. Complies with conditions as stated in contract
 - c. Demonstrates professional practices in teaching
 - i. Models correct use of language, oral and written
 - ii. Demonstrates accurate and up-to-date knowledge of content
 - iii. Implements designated curriculum
 - iv. Maintains lesson plans as required by school policy
 - v. Assigns reasonable tasks and homework to students
 - d. Acts in a professional manner and assumes responsibility for the total school program, its safety and good order
 - i. Takes precautions to protect records, equipment, materials, and facilities
 - ii. Assumes responsibility for supervising students in out-of-class settings
- II. Duties and Responsibilities, prescribed by Local School and System
 - a. Follows the Code of Ethics and Standards of Conduct for Educators as promulgated by the Georgia Professional Practices Commission to maintain a high level of ethical conduct in relationships dealing with students, with colleagues and with the public
 - b. Complies with all school rules, regulations and expectations prescribed by the school principal or other authority at the local school level in addition to all system policies, procedures and guidelines
 - c. Displays the proper attitude and cooperation necessary to function as an effective professional team member of the school staff; demonstrates respect for and acceptance of diverse opinions and views which may differ from one's own personal viewpoint.
 - d. Carries out other duties as may be assigned by the principal or Special Services director, which may include supervisory responsibilities, bus duty, hall or cafeteria monitoring, club or activity sponsorship, athletic coaching, coordinating special programs or functions, serving on committees, and so forth.
- III. Professional Development Plan – each professional employee is expected to develop a plan to assure continued professional growth and enhancement of job-related skills.
- IV. Performs other activities as may be required in specialized fields of instruction that are specific to a particular job assignment.

PHYSICAL REQUIREMENTS

Employees in this position must have the ability to: stand, walk, run, bend over, reach overhead, grasp, push, pull, move, lift and/or carry up to 75 lbs. waist height.

ESSENTIAL DUTIES
