Dear Parents/Guardians:

The Marlboro Township Board of Education is pleased to present its **Voluntary Student Accident Insurance Program for the 2018 - 2019 School Year**. An enrollment form and instructions have been made available online by logging onto [www.bobmccloskey.com](http://www.bobmccloskey.com). Attached please find a flyer providing highlights of the program. You may also obtain a copy of the enrollment form and brochure by logging onto the district's website at [www.mtpps.org.us](http://www.mtpps.org.us). Under the *District* tab, click on *Student Accident Insurance Program*.

This voluntary student accident insurance is available to all students who attend school within the Marlboro Township K-8 Public School District and consists of three (3) types of coverage – School Time, Around-the-Clock and Dental.

**At-School Coverage** costs **\$10.50** and will provide full coverage for accidents that occur during school time. The program provides coverage during which a student is in or on school premises during the days and months when school is in session. This program also provides coverage while the student is traveling to and from their residence to the school in any vehicle supplied by the school, and this coverage also extends to students participating in or attending activities sponsored solely by the school.

**Around-the-Clock Coverage** costs **\$72.00** and provides 24-hour coverage whether school is in session or not. This coverage also includes school sponsored activities and supervised sports.

**Dental Coverage (Accident Only)** costs **\$12.00** and is in effect 24-hours a day.

The Voluntary Student Accident Insurance Policy extends benefits to the student, and these benefits are explained in greater detail in the attached brochure.

**Please be advised that the Marlboro Township K-8 Public School District does not and can not provide a Compulsory Student Accident Program to the students. There are significant and controlling limitations on the liability issues of a public entity to students who are injured on school property.**

At this time, the Marlboro Township Board of Education **strongly** suggests that all parents/guardians consider this option and coordinate the purchasing of this policy as a supplement to your own health insurance program, especially parents/guardians of students involved in athletics or other school-sponsored activities.

Personal health insurance coverages vary in terms of deductibles and coinsurance, and this small investment in a voluntary student accident policy may be a valuable supplement to your current health insurance program.
