#### 5. Fire-fighting measures

Sweep up or vacuum up spillage and collect in suitable container for disposal. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. After removal flush contaminated area thoroughly with water.

Never return spills to original containers for re-use.

**Environmental precautions** Prevent further leakage or spillage if safe to do so. Do not contaminate water. Do not allow to enter drains, sewers or watercourses.

#### 7. Handling and storage

**Precautions for safe handling** Keep away from all ignition sources including heat, sparks and flame. Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Provide adequate precautions, such as electrical grounding and bonding, or inert atmospheres. Avoid inhalation of dust and contact with skin and eyes. Use only with adequate ventilation. Observe good industrial hygiene practices.
