



2018 – 2019 FAIRFIELD HIGH SCHOOL STUDENT PARKING

Information needed to purchase a student parking pass:

1. Parking Fee 2018-2019 school year: \$55.00
2. **COMPLETED** application – **MUST** be signed
3. Current/valid proof of insurance
4. Current/valid Driver License (DL)

*Driving to school is a privilege. **Only students who have purchased a parking permit are eligible to park at FHS during school hours.** Students found parking without a permit are subject to discipline action, being stickered or towed, and having a parking fee assessed to his/her student account.*

STUDENTS ARE ONLY PERMITTED TO PARK IN THE STUDENT LOT IN A NUMBERED SPOT.

STUDENTS ARE TO PARK IN THE FHS STUDENT LOT ONLY. THERE IS NO PARKING IN RESERVED AREAS: STAFF/VISITOR AREA, DROP OFF/PICK UP LOT, HANDICAP, FIRE LANE, ETC. **ANY STUDENT PARKED IN A NON - NUMBERED SPOT and/or OUTSIDE OF THE STUDENT PARKING AREA IS SUBJECT TO DISCIPLINE ACTION, BEING STICKERED and/or TOWED AT THE OWNER'S EXPENSE, and HAVING A PARKING FEE ASSESSED TO HIS/HER STUDENT ACCOUNT.** PARKING IS ON A FIRST COME BASIS. THERE ARE NO ASSIGNED PARKING SPOTS.

- A. Students parking on school property during school days/hours (7:30am – 3:00pm) are allowed to do so only with a **2018-2019** student parking pass. Upon leaving FHS for any reason (ie: early grad, transfer, etc) the parking permit will become invalid and must be turned in to the office immediately. Students who have a lost parking permit must inform the office immediately.
- B. Student parking spots are the white & yellow **NUMBERED SPOTS ONLY.** Parking permits must hang on the rear view mirror facing out. Permits must be visibly displayed and unobstructed.
- C. Students parked in the lower lot (yellow parking spots) **MUST MOVE HIS/HER VEHICLE BEFORE 2:45PM during the months of August – November.** VEHICLES NOT MOVED MAY BE SUBJECT TO TOWING AT THE OWNER'S EXPENSE.
- D. Students are expected to arrive and leave school in an orderly fashion and observe all safe driving procedures and regulations. Loud stereos, inappropriate driving, and/or recklessness are prohibited at all times. Students are expected to report inappropriate parking/unsafe driving/unauthorized visitors to the office.
- F. All students park at his/her own risk. Fairfield City School District/Fairfield High School is not responsible for any theft, vandalism, or damage to vehicles.
- G. All district policies, rules, regulations, student codes of conduct, and student attendance/tardy policies must be adhered to. Any violation or abuse of parking privileges may result in school issued consequences.
