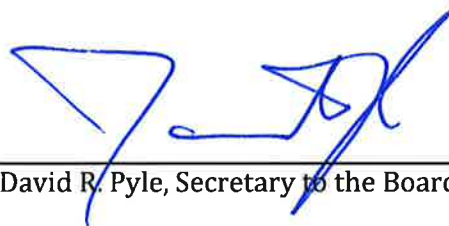
**8. MEETING ADJOURNMENT**
