Thank you for choosing our Summer Camp Program. Please take a look at the calendar of events on the reverse side. Listed below are just a few guidelines and reminders. We hope you find it helpful.

PLEASE REMEMBER

- All accounts are charged for the weeks you reserve on your summer contract. No credit or refund given for absences.
- All schedule changes must be made in writing "**30 DAYS**" prior to avoid being charged for that week.
- Tuition paid by credit card must be paid by the 1st Monday of each month. Tuition paid by check may come in weekly and must be received no later than the first day of their attendance each week they are enrolled.
- If weekly fees are not paid in full by the days listed above a \$10.00 late fee will be charged and your child will be not be able to attend summer camp until fees are paid. Please make checks payable to PYLUSD.
- All children must be signed IN and OUT daily by an adult 18 years or older. Children may not be dropped off at the curb or walk up without an adult present. **Picture Identification Cards/Driver's License WILL be required.**
- Label all items brought to the center (i.e. jackets, towels, lunch boxes, etc.). **We are not responsible for lost, damaged or stolen items.**
- Children are responsible to hold their own spending cash on specific field trips or on shaved ice days, etc. Please send the exact amount of cash, change may not be available.

EVERYDAY

- Dress your child in safe comfortable play clothes and don't forget sunscreen. Parents are responsible for applying sunscreen on their child or children each day.
- **Sandals and flip flops are NOT allowed for safety reasons.** Closed toe shoes are required for all field trips.
- Hats and water bottles are allowed and highly recommended.
- **Do not bring personal items** (such as cell phones, electronic games, iPads, toys, etc.)
- A morning snack and afternoon snack will be provided daily.
- Pack a lunch and drink daily unless participating in a special lunch activity. Hot lunch services are NOT available during the summer. Sweets & sodas are not recommended. **No food refrigeration or warming available.**

FIELD TRIP DAYS

- Children are required to wear our PYLUSD T-Shirt on all field trips. Please label your child's shirt with their name. Extra T-Shirts can be purchased for \$10.00. Children cannot attend the trip without wearing our T-shirt.
- If a child shows up without a camp shirt on a field trip day and time allows the parent can choose to return home for it or purchase a new shirt.
- All children must be at the center by time indicated on calendar. **The bus cannot wait.**
- Field trips will be a planned part of the Expanded Learning Child Care Summer Camp Program. Children will not have the option to stay back or arrive late after the group has left for a field trip. The center will be locked and you can return when the group returns from the field trip.
- All children are required to take the district or chartered bus to all field trips. Children may NOT be dropped off at a field trip location.
- Children may bring money (up to \$5.00) on specific Field Trips. They are responsible for their own money.
- Completely disposable lunches! Please **NO** lunch boxes, thermos or containers on field trip days.
- Children who do not adhere to program rules and policies, at the discretion of the Lead Teacher(s), may not attend the field trips for the safety of the child and other children. Parents will be notified and alternate care will need to be secured by the parent for that day.
