*** Unless otherwise indicated, district meetings and public hearings are held at the respective district's school.**

Posting Date: Fourteen days before meeting, not counting date of meeting or the day of posting.

Special Articles: Must be submitted thirty days before the second Tuesday in March (February 11), or 30 days before the date prescribed for the school district meeting, whichever is earlier.

Budget Posted: At the time of warrant - 14 days.

Candidates File: Beginning on the seventh Wednesday prior to the election, 10 days in duration.

NOTE: COMPUTATION, RSA 652:19: "When a date falls upon a Saturday or Sunday, the act shall be performed on the following Monday.

Per Municipal Budget Act, RSA 32:5, a public hearing shall be held on each budget not later than 25 days before each annual or special meeting; public notice, and time of which shall be given at least 7 days in advance.

On bond issues, a public hearing shall be held at least 15 days prior to the district meeting, but no more than 60 days. Notice of time, place and subject of such hearing shall be advertised in newspaper at least 7 days prior to public hearing.
