

Life High School Waxahachie Parental Involvement Policy 2018-19

Part II. Description of how schools will implement required school parental involvement policy components

4. Life High School Waxahachie will provide each parent an individual student report about the performance of their child on the State assessments.
5. Life High School Waxahachie will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph-
 - The state's academic content standards
 - The state's student academic achievement standards
 - The state and local academic assessments including alternate assessments
 - The requirements of Part A
 - How to monitor their child's progress, and
 - How to work with educators
6. Life High School Waxahachie will provide information and training to help parents work with their children to improve their children's academic achievement, using technology, and general information as appropriate, to foster parental involvement by:
 - Hosting at least 2 parenting nights per semester
 - Communicating via Mustang Messages, Remind 101, Twitter, etc.
 - Encouraging Parent-Teacher Conferences
 - Encouraging parents to utilize Parent Portal

Life High School Waxahachie will take the following actions to ensure that information related to the school and parent-programs, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language parents can understand:
