Colonel Howard Nichols School has been opened since September, 1961. The school was modernized during the 2007-2009 school years. The school is located on an 11-acre plot of land in Northeast Bakersfield.

The school is named for Colonel Howard Nichols, a Colonel in the armed forces during World War II. Colonel Nichols was a local contractor following the war. He built many of the houses in the Nichols School area. He donated the land for the school to the Bakersfield City School District.

Nichols Elementary offers the Boys and Girls After School Program, Migrant Tutoring and enrichment activities such as Academic Pentathlon, Oral Language, and Math Bowl.

School Facility Conditions and Planned Improvements (Most Recent Year)

Nichols School was built in 1959 and Modernized in 2009. It sits on 11.14 acres of which 5.9 acres is playground. This school has 37 classrooms, a multi-purpose facility, library, speech room, IMC, computer lab, pre-k room and tutor/after school program room. The campus also has a staff lounge.

District Funds were used to provide and install 1 new relocatable classroom for growth.

The custodial staff adheres to a weekly cleaning schedule that includes classrooms, restrooms, cafeteria and kitchen areas.

The District’s Mobile Maintenance Team visits the school site at least twice a year. Maintenance emergencies are addressed immediately. District personnel maintain the grounds at least once every two weeks.

This site also is maintained to ensure a clean, safe, and functional facility as determined pursuant to a Facility Inspection Tool developed by the State of California Office of Public School Construction.

Many classrooms have parent volunteers that works closely with the teacher to coordinate classroom activities and special events. Parent involvement is encouraged through our FACE, PTA, School Site Council, English Learner Advisory Committee, and Parent Education Sessions. Nichols is host to a district FACE Parent Involvement Center that is operated by a FACE Liaison. The goal of these committees and the parent center are to increase two-way communication between the home and school.

A monthly newsletter is sent with information about school events and contact information for parents with questions. The phone messaging system is also used to disperse information. Professional Development (Most Recent Three Years)

Professional development is designed to provide continuous learning opportunities for administrators, teachers, and classified personnel. Training opportunities affirm the basic philosophy of education that learning is a lifelong process that contributes to the well-being of the students, teachers, administrators, and community. Professional Development is an essential component of effective instruction and student learning.

All training revolves around identified needs of students and adults for the purpose of the improvement of instruction and increasing content knowledge. Central to all training are student achievement data, district focus areas, the Common Core State Standards, the state adopted standards-based instructional materials, and strategies to effectively teach the academic content standards to all students.

The district created professional development based on the Common Core State Standards for teachers and administrators. The modules included a Common Core overview, Mathematical Practices, Cross-Curricular/Evidence Based Writing, Text Complexity/Academic Vocabulary, including ELD standards for California. We also provided extensive professional development for Professional Learning Communities through our Service Delivery Model. On-site coaching and support is provided by academic coaches for reading/language arts, mathematics, science and writing. The district provides time and resources for collaboration, planning, and professional development. Additionally, we provided professional development on Multi-Tiered Systems of Support and Support to school and district teams.

Teachers new to the District received four days of professional development prior to the beginning of the school year focused on orientation to District and school site policies and services, Common Core State Standards, classroom management, curriculum and pacing, and setting up the classroom. Teachers in their second year with the District received two days of professional development prior to the beginning of the school year focused on best practices for improving student achievement.

New teachers with California preliminary credentials received professional development through the Beginning Teacher Support and Assessment (BTSA) program. The focus of training was in the Formative Assessment for California Teachers (FACT), California Standards for the Teaching Profession (CSTP), meeting the California Induction standards, and the California Academic Content Standards. Each beginning teacher was assigned a veteran teacher who served as a mentor. The mentors received on-going professional development in FACT, coaching strategies, and instructional techniques. Professional development was provided through individual mentoring, monthly meetings, and after-school workshops.

Intern teachers received professional development at monthly meetings focusing on the initial teaching skills of the CSTP including classroom management, lesson planning, assessment, and establishing a climate that is conducive to student achievement. Each Intern was assigned a mentor that provided day-to-day support in these areas as well as advisement toward meeting credential requirements. Mentors received monthly professional development in meeting the needs of Intern teachers. Interns also received coursework and supervision from universities partnered with BCSU to provide the Intern Program.
